INSTRUCTIONS:

BREEDING FEE: Make checks payable to Triple M Stables, LLC

Stud Fee: \$500.00

Enclose a copy of the mare's papers front and back.

Fill out and sign breeding contract.

Board will be paid on arrival of your mare for the first 30 days. Board is \$10.00 a day.

Copy of your vet's immunizations records, including Strangles, negative uterine culture
(Copy of your current coggins, within 12 months)

We only accept immunizations given by your veterinarian.

Once the Stallion Owner has accepted and executed the breeding contract, a copy will be sent to you. At the time the mare is delivered to A Walking Horse Ranch for breeding, board will be collected for the first 30 days in the amount of \$300.00.

BREEDING CONTRACT FOR LIVE COVERAGE

Mare Owner understands and agrees the mare(s) shall be in healthy breeding condition and that each mare shall have proof of a negative uterine culture, negative coggins, photocopies of both sides of mare's registration papers (if mare is registered). Mare will not be allowed on property without all the above.

Mares that are not halter broke will not be accepted. If you cannot easily halter your mare and walk her on a lead rope, don't bring her. We have to be able to safely handle her during breedings, and vet checks with the ultra-sound.

The mare owner agrees that the Stallion owner, Manager or any Staff will not be responsible for accident, sickness, injury, or death to the above stated mare or to any foal.

It is also understood the mare owner will not be responsible for any disease, accident or injury to the Stallion.

Mare owner understands and agrees that should the Stallion die or become unfit for breeding as determined by a licensed veterinarian, this contract becomes null and void. Absolutely no refunds under any circumstances.

Mare owner shall pay the breeding fee in the amount of \$500.00 in advance to bringing their mare. Any additional fees for mare care shall be paid to Triple M Stables, LLC. If any fees are not paid, the stallion owner reserves a right to assert a breeder's lien. All costs incurred in collecting delinquent charges shall be the responsibility of the mare owner. These costs are including, but are not limited to the following: court costs, attorney's fees, skip tracing, etc.

The stallion owner guarantees a live foal from the breeding contract: Live foal as defined as a foal that stands and nurses. Should the mare prove not be in foal, aborts her foal, or the foal is stillborn, mare owner shall notify the stallion owner within 7 days of foaling or the date the mare is proved not to be in foal or loses her foal. A written statement from a licensed veterinarian verifying that the mare has slipped or produced a nonviable foal must be sent to the stallion owner.

This guarantee means the stallion owner shall give the mare owner a free season to the stallion the following year only, subject to the stallion being alive, able to breed and still owned by the stallion owner. The mare owner will be subject to mare care and expenses for any rebreeding.

In the event the mare aborts, the mare owner shall certify to the stallion owner that the mare was accurately and properly administered vaccines to prevent the mare from aborting: such as booster rhinopneumonitis vaccinations administered as indicated by the individual drug manufacturer.

Mare owner acknowledges that the breeder STRONGLY recommend pregnancy checks via ultra-sound at 17 days, and by palpation at 45-60 days. Breeder strongly recommends Rhino vaccinations at 5-7-9 months, plus normal vaccinations appropriate for the mare's locale.

Insurance of the mare is strongly recommended.

The breeder will not be held responsible for any mare not conceiving or aborting during pregnancy. This contract may be assignable and transferable upon approval from Triple M stables, LLC, stallion owner.

BOARDING CONTRACT: Mare owner will sign-boarding contract on the date mare is dropped off.

Veterinarian Mare Care: Mare owner will be responsible for setting up an account with the local veterinarian we use for ultra-sounds to check for pregnancy. These will be done at the barn. The vet will also charge an additional farm call. The farm call can be split among mare owners if applicable.

COLOR GUARANTEE: Stallion owner guarantees a color foal. If the foal from this breeding is not of color (i.e.: cremello, perlino, palomino, champagne, smoky cream, buckskin, or a combination of white with any of the above), than the contract mare, or a substitute mare may be booked the following year at no additional stud fee. All other fees associated with the breeding of the mare, boarding, shipping, collection, veterinarian fees, stallion handler, etc. are the responsibility of the mare owner. Chestnut/Sorrell mares are 100% guaranteed palomino foals.

Smoky Black Foal Guarantee: If your mare produces a smoky black foal, you have the following option: ONE FREE rebreed allowed up to one year from the date of birth of the smoky black foal. Again, all other fees, stallion handling fee, veterinarian, collection, shipping, board, mare care, etc., are the responsibility of the mare owner. ONLY the stud service is FREE. All other charges incurred by the mare owner are the responsibility of the mare owner. If the mare has a second smoky black foal on a free rebreed, the free rebreed does not apply for a third breeding, same mare or different mare. Only one free color rebreed allowed per contract.

The stallion owner will not sign registration papers for the foal until all fees are paid in full.
